Identification and referral of refugees for a) resettlement programmes b) humanitarian admission programmes c) community sponsorship programmes	Austria implemented three national resettlement programmes (2013-2017). Within the first and second resettlement programme, UNHCR as well as civil and clerical organisations were requested by the Ministry of the Interior to identify candidates for admission and make referrals. Within the third resettlement programme, submissions were only made by UNHCR. The procedural steps listed in this table refer to all programmes.
Selection of refugees for a) resettlement programmes b) humanitarian admission programmes c) community sponsorship programmes	The Ministry of the Interior decides on the admission of candidates on a dossier basis (no selection missions).
Pre-departure assistance a) resettlement programmes b) humanitarian admission programmes c) community sponsorship programmes	The IOM provides pre-departure measures, such as health assessments, travel health assistance and pre-departure orientation.

The Working Group for integration activities (ARGE) supported the Ministry of the Interior with the reception of the admitted persons.
